2.	New Programs - Dr. Amy Conditt and Dr. Tavia McLeod	that want to get that initial licensure. We have put two cohorts through. It has been very successful. If you know anyone that is interested in going into teaching, it is great for those adult educators that want a second career/career changes. Dr. Andrew Burnham is the director.	
		Dr. Conditt: We also offer the Curriculum and Instruction Program (CAI). This program is a perfect program for a certified teacher that does not want to go into leadership and just wants to enhance their teaching skills. The price is around \$13,000. It is 30 hours and it is all online. We tried to launch it this spring and did not have enough interest. If you know anyone in the school system who would be interested in this program, please let them know.	
		Dr. McLeod: New EDS Program – We have made two tracks with our EDS program. It was instructional accountability and leadership. Now we have divided that into an AI track and an accountability track and those will be available this fall. The accountability track is the same except for each core class for licensure will have one added AI assignment. The AI track will have the 20 hours core licensure courses and then 9 AI courses added to that. We are also redoing the Capstone course. It will no longer do any kind of research except for in what was originally the Capstone course. Now it is going to be a summative assessment kind of similar to the one that is in our Master's program where we research different strategies and schools and collect a bunch of	

	data and use AI. The accountability track, we are taking out the research, we are adding a law class and also an inclusive diversity type class. We are approved through the graduate studies and our courses are approved. So far, on one of our enrollment counselors hot list, there are 20. No matter what track they are on either AI or accountability, they all take the first 20 hours together and the last part of their third semester and 4 th semester is when they do their concentration courses. So that means the field experience has to be reworked.
